GENERAL INFORMATION SECTION

The following is a summary of the information gathered from LACPRS intake questions administered to John Doe on September 1, 2005. The summary is based on the treatment participant's self report regarding recent (previous 30 days) and past alcohol and other drug use; medical and psychiatric problems and treatment; employment and legal issues; and family and social support.

John is a 28 year old, white male. John reports that he has visual and hearing and mobility disabilitie(s).

John has not given written consent to be contacted for a follow-up interview.

The participant is being admitted to the outpatient counseling program at this agency's facility site. John will participate in the following special treatment/recovery program - None. John is not a Proposition 36 participant.

The principal source of referral was 12 Step Mutual Aid. John has participated in 0 treatment episode(s) prior to the current episode.

ALCOHOL AND OTHER DRUG SECTION

John reported that his primary drug problem is heroin and he begun using at the age of 13. John has used his primary substance 20 day(s) out of the last 30 and the usual route of administration is other.

The participant reported other club drugs as the secondary alcohol or other drug problem.

John reported that he used alcohol on 7 day(s) in the past 30.

The participant reported needle use on 0 day(s) in the past 30. The participant denied use of needles to inject drugs in the past 12 months.

EMPLOYMENT SECTION

John reported that he completed 12 years of school. He was not enrolled in school at the time of admission to this program. John was not enrolled in a job-training program. Currently, he is unemployed (not seeking). John received pay for working 0 day(s) out of the prior 30 and reportedly earned \$0.00.

LEGAL SECTION

John reported that he is not experiencing any current legal percedeings. The participant has engaged in 0 day(s) of illegal activity for profit during the last 30 days. He has been arrested 0 times in the past 30 days. Furthermore, the participant reported spending 0 day(s) in jail during the past 30 and 0 day(s) in prison during the past 30 days.

MEDICAL SECTION

John reported that he has experienced physical health problems on 2 day(s) out of the previous 30. He has visited the emergency room 15 times in the last 30 days and has remained overnight at a hospital for 30 day(s) out of the prior 30.

With regards to communicable infections and diseses, the participant reported that he:

- * has never been diagnosed with tuberculosis;
- * has never been diagnosed with Hepatitis C;
- * has never been diagnosed with a sexually transmitted disease(s);

John has tested for HIV/AIDS and the participant has received his test results.

PSYCHIATRIC SECTION

John has been diagnosed with a mental illness. He has received outpatient empergency services for mental health needs 0 times in the last 30 days and has remained at a hospital or psychiatric facility (more than 24 hours) for 30 day(s) out of the prior 30. The participant does report taking prescribed medication for mental health needs.

FAMILY AND SOCIAL SUPPORT SECTION

The participant reports that he is homeless. During the past 30 days John has resided with someone who uses alcohol or drugs on 0 day(s). He reported 0 day(s) of serious conflict with his family.

John reported no physical abuse during the past 30 days. John reported no sexual abuse during the past 30 days.
